I accept the following General Conditions: This charge is not subject to a dispute once the trip has commenced. No refund will be applicable for cancellation of hotels and tour packages received within 45 days of departure. No refund will be applicable for cancellation of cruises received within 60 days of departure. No refund will be applicable for any portion of the program not used during the operation of the tour. The Tour Operator reserves the right to make changes in any itinerary in the event it becomes necessary to insure the safety, comfort or well being of the passenger. Such changes will be made without penalty to the operator.

If the package includes an airline ticket originating in the USA, it is the passenger responsibility to verify the correct spelling of the names listed in this confirmation, and also to verify with the airline at least three days prior to departure, your flight numbers and flight times. Ask the airline to enter your home telephone number in the record, your frequent flyer number and request seat assignments.

All consumers payments are deposited into an escrow account and funds are not released until services are provided by our suppliers.

Cancellation of Land Services (hotels, transfers and tours): For cancellation of received in writing more than 91 days prior to departure will be subject to \$250 per person plus a 5% fee charged by the Credit Card Processors. plus all charges imposed by hotels, overseas ground operators and suppliers involved in the operation of the tour. No refund will be made for cancellations received within 60 days of departure.

No refund will be made for any change and/or cancellation of service and/or accommodation made by the passenger during the operation of the tour.

Cancellation of Cruises: Penalties vary according to the particular policy of each cruise line. But as a general rule, no refund (less \$250 per person) will be given for cancellations received within 91 days prior to departure. Medically certified cancellations will be subject to 50% of the full penalty.

Cancellation of airline reservations: There is no refund once the airline ticket has been issued. To protect the airfare the airline ticket will be issued immediately after we receive this form duly signed. The airfare is only guaranteed after the ticket has been issued.

Visa Information: The only Latin American country that requires a visa for United States citizens is Brazil, and it must be obtained in the USA. If you are traveling to Brazil from Bolivia, Colombia, Ecuador or Peru a yellow fever vaccination is mandatory . If you visited Bolivia, Colombia, Ecuador or Peru within six months prior to your trip to Brazil a yellow fever vaccination is mandatory. Chile and Bolivia requires an entry fee of \$100 in cash.
